The Issuer is operating in the private education market. It provides primarily international education services in Canada and franchising services in China. Its educational services are currently for international junior and senior high school students. The Issuer's core strategy regarding business development remains to acquire private schools in Canada and adds more franchised education service providers (known as "EA clubs") to its network of clubs in China.

The franchising revenue in China decreased in the last few quarters as some EA Clubs have terminated the franchising agreements with the Company during the year ended August 31, 2016 and in the last few quarters.
