HealthSpace Data Systems Ltd. Announces Listing Approval and Name Change

VANCOUVER, BC – November 27, 2015 - HealthSpace Data Systems Ltd. (the “**Company**” or “**HealthSpace**”) is pleased to announce the final approval of its Canadian Stock Exchange (the “**Exchange**”) listing, as described in its final prospectus filed on November 4, 2015 and receipted by the BC Securities Commission, Alberta Securities Commission, and Ontario Securities Commission. A copy of the final prospectus may be obtained from SEDAR. As a result of the prospectus being receipted, 18,139,167 special warrants were converted to the same number of common shares of HealthSpace. The Company anticipated that it will start trading on the Exchange effective at the opening on November 30, 2015 under the symbol “HS”.

The company is also pleased to announce that it has changed its corporate name to HealthSpace Data Systems Ltd., effective November 9, 2015.

“We are very excited to have completed our go-public transaction and to officially launch our new corporate identity with a name that aligns to our Company’s value proposition,” said Warwick Smith, CEO of the Company. “HealthSpace is a leader in our space and we are very well positioned to continue to expand our presence across North America and build shareholder value as we execute our growth strategy.”
