On May 11, 2017, the Acquiror subscribed for 200,000 Units in the second tranche of a private placement of the Issuer at a price of \$0.20 per Unit (the “Offering”). Each Unit was comprised of one common share in the capital of the Issuer (each a “Common Share”) and one-half of a Common Share purchase warrant. Each whole warrant (“Warrant”) is exercisable into one Common Share of the Issuer at a price of \$0.30 per Warrant for a period of twenty-four (24) months from the closing date.

Item 3 – Interest in Securities of the Reporting Issuer

The Acquiror subscribed for 200,000 Units of the Issuer, as described in paragraph 2.2 above. The 200,000 Common Shares comprising a part of the Units represent approximately 0.79% of the issued and outstanding Common Shares, and together with the 100,000 Common Shares issuable upon exercise of the Warrants comprising a part of the Units, represent approximately 1.19% of the issued and outstanding Common Shares, on a partially diluted basis.

Prior to the Offering, the Acquiror owned 3,294,000 Common Shares of the Issuer, 1,726,750 Common Share purchase warrants and stock options to purchase 150,000 Common Shares, representing approximately 13.63% of the issued and outstanding Common Shares of the Issuer on a non-diluted basis, and 19.86% on a partially diluted basis.

Following completion of the Offering, the Acquiror holds 3,494,000 Common Shares and 1,826,750 Common Share purchase warrants, representing approximately 13.92% of the outstanding Common Shares on a non-diluted basis. If the Acquiror were to exercise all of her convertible securities she would own 5,470,750 Common Shares, representing approximately 20.21% of the Issuer's then outstanding Common Shares, on a partially diluted basis.
