Between May 11, 2016 and June 7, 2016 the Offeror acquired an aggregate of 638,000 Common Shares of the Issuer on the open market at prices ranging from \$0.03 to \$0.05 per Common Share (the “**Acquisition**”). On June 8, 2016, the Acquiror acquired control and direction over an additional 800,000 Common Shares, for an aggregate total of 7,305,772 Common Shares of the Issuer, representing approximately 12.3% of the Issued and outstanding Common Shares of the Issuer.

In addition, the Acquiror has control and direction over an additional 800,000 Common Shares, for an aggregate total of 7,305,772 Common Shares of the

Issuer, representing approximately 12.3% of the issued and outstanding Common Shares of the Issuer.
