On June 23, 2016 the Acquiror subscribed for 875,000 units (“**Units**”) in a private placement of the Issuer at a price of \$0.20 per Unit (the “**Offering**”). Each Unit is comprised of one Common Share and one-half of one Common Share purchase warrant (each whole warrant, a “**Warrant**”).

#### Item 3 – Interest in Securities of the Reporting Issuer

The Acquiror acquired 875,000 Units of the Issuer. The Units are comprised of 875,000 Common Shares and 437,500 Warrants. The 875,000 Common Shares and 437,500 Warrants, comprising the Units, represent approximately 5.7% of the issued and outstanding Common Shares of the Issuer and 24.2% of the Warrants issued pursuant to the Offering, respectively.

Prior to the completion of the Offering, the Acquiror owned 7,756,005 Common Shares of the Issuer representing approximately 65.8% of the issued and outstanding Common Shares of the Issuer.

Upon completion of the Offering, the Acquiror will own 8,631,005 Common Shares of the Issuer representing approximately 56% of the Issuer's issued and outstanding Common Shares on a non-diluted basis. If the Acquiror were to exercise all of its convertible securities it would own 15,099,595 Common Shares, representing approximately 69% of the Issuer's then outstanding Common Shares, on a partially diluted basis.

The securities were acquired for investment purposes. The Acquiror has a long-term view of the investment and may, depending on market and other conditions, or as future circumstances may dictate, from time to time, on an individual or joint basis, increase or dispose of some or all of the existing or additional securities it holds or will hold, or may continue to hold its current position. The Acquiror currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (j), above. Depending on market conditions, general economic and industry conditions, the Issuers business and financial condition and/or other relevant factors, the Acquiror may develop such plans or intentions in the future.

The Acquiror entered into a subscription agreement with the Issuer to acquire 875,000 Units at a price of \$0.20 per Unit. Each Unit is comprised of one Common Share and one-half of one

Warrant. Each Warrant entitles the Acquiror to purchase one Common Share at an exercise price of \$0.30 per Common Share for a period of twenty four months from the closing of the Offering.
